10,797.30 A temporary part-time position has been filled in the Maintenance department to solely run the disinfectant machine for all rooms on campus. A part-time position is currently helping with COVID-19 tracking. A part-time position is working in the Distance Learning area helping with the transition for students and faculty to on-line learning.

Prior to the pandemic, the college (MCC) managed most aspects of its student admissions and student-intake processes through the Department of Student Services. However, the additional workload created by the pandemic, hampered admissions processes and negatively impacted student enrollment. Thus, MCC fast tracked its plan to create a Department of Admissions, Counseling, and Student Support services, for which, these funds provided dedicated office equipment (computers, scanners, copiers, and IT infrastructure). MCC believes this new department will foster increased enrollment and greater student success through more and improved one-on-one assistance.
