This scholarship fund commemorates the late Carol Bond and her lifelong devotion to environmental education.

Carol was one of the first certified Environmental Educators in the state of North Carolina. Carol also served on many NC One Water committees.

Official transcript with college/university seal

One \$1,000 scholarship plus free attendance to the 2022 NC One Water (formerly NC AWWA-WEA) Annual Conference

EDUCATION LEVEL/INSTITUTION

Pursuing a degree at a community college in North Carolina

PROGRAM/COURSE OF STUDY

Environmental science or environmental education

CUMULATIVE GPA

Greater than 2.75 (on a 4.0 scale)

CITIZENSHIP AND RESIDENCY

Must be a U.S. citizen

MEMBERSHIP REQUIREMENTS

Preference will be given to members of an NC One Water/NC AWWA-WEA student chapter.

RENEWAL ELIGIBILITY

This scholarship cannot be renewed; however, recipients are welcome to reapply for the scholarship annually.

PAYABLE TO

Paid directly to financial office of recipient's educational institution

CONFLICT OF INTEREST

The applicant must not be related to scholarship sponsors nor employed by such sponsors and not an employee of nor related to officer or director of NC One Water, nor to any member of the Endowment Committee.

Please do not submit any additional materials with your application. Materials that are not requested will not be reviewed nor will they be returned to you.

Notification letters will be mailed to all applicants by June 1, 2022.
